- Warranty Starts from the date of the purchase from an Authorized Dealer (AD) unless otherwise noted below.
 - Warranty covers replacement parts and labor per the Labor Schedule attached.
 - Warranty does not cover normal wear items, ie, tires, brakes.
 - Warranty for rentals or taxis or other excessive use application is limited to six (6) months and must be registered as such.
 - Warranty for the Frame shall be free from defect in materials for four years; frame is defined as chassis, which does not include drive trains, suspension, roof supports, paint and corrosion.
 - This Warranty applies only to EEV AD's, and AD end user sales.
 - If the AD purchased vehicles are not sold or transferred within 6 months from the date of the purchase from EEV, the Limited Warranty will begin from the last day of the third month of the purchase from EEV.
 - This warranty is to original end user only and is not transferable

This remedy precludes all other remedies including any lawsuits, claims or other proceedings alleging strict liability, negligence of contract or any cause of action. **HDK** reserves the right to improve or change the design of any **HDK** vehicle or battery charger without assuming any responsibility to modify previously manufactured vehicles.
